About the Awards

What are the Clarivate Library Innovation Awards?

The Clarivate Library Innovation Awards recognize and celebrate innovation, creativity, and real-world impact in academic, national, and public libraries worldwide. The program aims to showcase transformative projects that have advanced library services, technology, community engagement, and operational excellence within the past two years.

Why were these Awards created?

The Awards support and recognize libraries driving positive changes, promoting thought leadership, inclusion, sustainability, and innovation across the global library community.

This is intended to be a platform for you to showcase your Library's achievements and to be an inspiration to your peers in the library industry across the world.

Who organizes and manages the Awards?

The Awards program is managed by Clarivate, in partnership with the respective independent international User Groups as part of our joint commitment to supporting libraries and showcasing excellence across the industry.

Are these Awards global?

Yes. The Awards are global in scope, welcoming entries from academic, national, and public libraries worldwide.

Eligibility

Who can participate?

The Awards are open to any institution that is a member of ELUNA, IGeLU or IUG, or is part of a Library Consortium.

Can small or medium-sized libraries apply?

Yes. Libraries of any size, budget, or geographic region are encouraged to apply, provided they can demonstrate measurable impact or innovative approaches.

What projects or initiatives are eligible for submission?

Projects or initiatives must have been launched or significantly advanced within the past 24 months. They should demonstrate innovation that has driven measurable impact in areas such as community outcomes, patron engagement, student success, operational excellence, digital inclusion, accessibility, sustainability, or any other priorities aligned with your institution's mission.

Do projects need to involve Clarivate products?

No. Use of Clarivate products is not mandatory. Submissions can highlight initiatives that are totally independent, partially related, or fully supported by Clarivate solutions.

Are there any restrictions?

Institutions currently in an RFP process with Clarivate or planning to publish one before July 2026 are not eligible to enter.

Can collaborative or consortium projects be submitted?

Yes. Collaborative submissions from consortia, library networks, or partnerships are welcome, provided the participating libraries clearly define their roles and individual contributions.

Award Categories

What are the award categories?

There are four main award categories, each corresponding to its respective community group:

- ELUNA Member Library Innovation Award
- IGeLU Member Library Innovation Award
- IUG Member Library Innovation Award
- Library Consortia Innovation Award

How many winners are selected?

In each category, three finalists will be selected. Each finalist will receive two all-expense-paid passes to their respective User Group conference. From the three finalists in each category, one overall winner will be announced during the User Group event.

Application Process

How can my institution apply?

What should my submission include?

Submissions should answer these questions:

Describe your project or initiative. Provide an overview of your project, including its goals, timeline, the challenge you faced and the opportunity it aimed to address.

What makes this project innovative or unique? Explain what distinguishes your initiative – for example, new ideas, creative partnerships, use of technology, or novel service models.

What measurable impact or outcomes has your project achieved? Describe how your project has benefited patrons, students, staff and/or the community. Include any supporting metrics, testimonials, or evidence to demonstrate results.

How do you ensure sustainability and scalability? Explain how this initiative could be maintained, expanded, or replicated in the future. What lessons have you learned that others could apply?

How does your project reflect inclusion, accessibility, and/or alignment with your institution's mission? Share how your initiative supports diversity, accessibility and / or equity, and how it advances your library's strategic goals.

Can multiple projects be submitted?

Yes. Institutions can submit more than one project as long as each is distinct and meets the eligibility criteria.

Is there an application fee?

No, participation is free.

Evaluation and Judging

Who will review, score, and adjudicate the applications?

An independent panel of judges from across the global library community have volunteered for their time to review and score submissions against a transparent scoring rubric. The current panel includes distinguished members of the library community:

How do you ensure impartiality and avoid conflict of interests in the judging process?

Each application will be randomly assigned to a judge who has no affiliation or connection with that Library, or its associated User Group. For example, an application from an IGeLU member institution in Spain will be assigned to a Judge who has no affiliation with IGeLU and is based in another geographic region.

How will submissions be evaluated?

Each submission will be scored based on:

Innovation & Originality	20%	Alignment to Mission/Strategy	10%
Impact & Outcomes	20%	Inclusion & Community Engagement	10%
Scope & Scale	10%	Role of Technology	5%
Sustainability & Future Planning	10%	Clarity & Quality of Submission	15%

Recognition and Awards

What do winners and finalists receive?



Conference participation

Each of the 3 finalist libraries in every category will receive an all-expenses-paid pass for two library staff members to attend their relevant 2026 international User Group conference (ELUNA, IGeLU, or IUG). This includes travel, accommodation, and event registration costs for the two delegates from each of the finalists in each category.



Recognition

The three finalists in each category will be recognized on Day 1 during the opening plenary of the User Group conference, with Award certificates presented by senior Clarivate leaders. The overall winner in each category will be announced on Day 3 and presented with the Clarivate Award Trophy.



Industry Showcase

Finalists and winners will be offered the opportunity to be featured globally across Clarivate websites, in the press, and as part of future webinars and case studies. Each winning institution will also receive a Clarivate digital 'Library Innovation Award Winner' banner for their website.
